The following terms and conditions are in an integral part of this application for appearance bond No. _____ dated _____ for which BANKERS INSURANCE COMPANY or its Agent shall receive a premium in the amount of

_____ (\$ _____) Dollars and the parties agree that said appearance bond is conditioned upon full compliance of all said terms and conditions and is a part of said bond and application therefore

1. BANKERS INSURANCE COMPANY, as bail, shall have control and jurisdiction over the Defendant during the term for which the bond is executed and shall have the right to apprehend, arrest and surrender the Defendant in the proper officials at any time as provided by law.
2. In the event surrender of defendant is made prior to the time set for Defendant appearances, and for reason other than as enumerated below in paragraph 3, then Defendant shall be entitled to a refund of the bond premium.
3. It is understood and agreed that the happening of any one of the following events shall constitute a breach of Defendant's obligation to BANKERS INSURANCE COMPANY hereunder, and BANKERS INSURANCE COMPANY shall have the right to forthwith apprehend, arrest and surrender Defendant, and Defendant shall have no right to any refund of premium whatsoever, Said event which shall constitute a breach of Defendant obligation hereunder are:
 - a. Defendant shall depart the jurisdiction of the court without the written of the court and BANKERS INSURANCE COMPANY, or it's Agent.
 - b. If Defendant shall move from one address to another to another without notifying BANKERS INSURANCE COMPANY, or it's Agent in writing prior to said move.
